Please be advised that we have no responsive "notice of a job opening for the position of Deputy Director" of MHLS.


Regarding your request for resumés of Deputy Directors for the past five years, enclosed please find copies of the responsive resumés for the current Deputy Director Eugene Myers (August 2015 to the present) and former Deputy Director, now Director, Michael Neville (January 2013 to June 2014). Please be advised that the resumés have been redacted for personal privacy reasons, to exclude home addresses, telephone numbers, personal email addresses, and private employment unrelated to the public position. See Public Officers Law §§ 87(2)(b), 89(2)(b).

The Deputy Director line (position number 96001552) was vacant from 2010 to 2013. That line was reclassified in August 2015 as "Special Programs Coordinator." Enclosed please find a personnel printout reflecting that reclassification of position number 96001552.
